The proceedings of the meeting commenced with recitation from the Holy Quran by Mr. Tariq Mahmud Gill, Registrar, UAF.

At the outset, the Academic Committee offered "Fatiha" on the sad demise of Prof. Dr. Muhammad Azam Khan, Dean, Faculty of Agri. Engg. & Technology.

The Academic Council further offered Fatiha on the sad demise of sister of Prof. Dr. Muhammad Jaffar Jaskani, Director ORIC and mother of Dr. Summar Abbas Naqvi, Associate Professor, Institute of Horticultural Sciences. The Academic Council prayed Almighty Allah to keep departed souls in eternal peace and grant courage to the bereaved families to bear this irreparable loss with fortitude.

Before taking up regular agenda item, the Vice Chancellor addressed the house as follows:-

"Welcome, this is first meeting of year 2024. We are setting the tone for 2024 and as we have already reviewed 2023 as a very successful year. I am hoping that 2024 will be a better year. Today's major agenda is about reform of undergraduate programs which is a compliance to the new undergraduate policy given by Higher Education Commission.

The agenda was placed in the last meeting. There were observations, particularly in terms of the philosophy of change which is making education pyramid with a strong foundation of general education language skill, computing skill, mathematics to be followed by specialization.

We think that it is still not fit for presentation to this house because there are Councils' requirements that could be the case with the Engineering Faculty also. I wonder if the Engineering Faculty was able to absorb it or they have also challenges. As per HEC Undergraduate Policy there is requirement of thirty credit hours of general courses in each Scheme of Studies. The Veterinary Faculty has already ten general credit hours courses in the existing Scheme of Studies of DVM degree program. If they include twenty new general courses, the total program of this faculty may be out of range. Whether the engineering Faculty has challenges like this? This is lesson for PVMC also. Have a round table meeting with PVMC. If Engineering Council has agreed with general courses it is good argument to put forth before the PVMC. If Engineering Council has adopted the education policy thus PVMC must follow for DVM program.

In previous meeting it was agreed that NCRC of each program must be undertaken and may not be violated. If we include thirty credit hours of general courses, the NCRC must also be respected. We cannot create everything parallel. The other important issue is that we should create not only the broad foundation but also learning process in the form of elective courses, in the form of skill development courses and internship etc.

We should create flexibility to the large extent. As we are coming with revised Scheme of Studies thus it is opportunity for us to give space to elective and skill development courses etc. so that during the specialization phase it may make the graduate life-long learner employable. We have to give extra skill beyond the curriculum to the students. This is an opportunity to formulize extra curricula in the revised Scheme of Studies. We are running the skill development programs for the last one year in each faculty.

Prof. Dr. Muhammad Sarwar Khan, Dean, Faculty of Agriculture informed me that he attended the meetings of BOS of Teaching Departments. The grades which are supposed to be discussed in BOS are not being discussed.

I request all to ensure the discussion of grades in BOS. It is quality assurance mechanism. More than two thousand courses are offered in one semester. The Controller of Examinations office cannot compare the answer sheets with award lists. The quality assurance/filter must be applied at departmental level. You are requested to make ensure that the grades are properly discussed in BOS of every department. Let's begin with the agenda."

Item No. 1 REVISED SCHEME OF STUDIES OF BSC (HONS) DEGREE PROGRAMS OFFERED BY THE FACULTY OF AGRICULTURE UNDER HEC UNDERGRADUATE POLICY 1.1

Prof. Dr. Muhammad Sarwar Khan, Dean, Faculty of Agriculture briefed the house about Revised Schemes of Studies for B.Sc. (Hons) degree programs being offered by the Faculty of Agriculture. He added that the Revised Schemes of Studies are in line with HEC Undergraduate Policy 2023 and aligned with NCRC of HEC. These Schemes of Studies have been discussed in the concerned Board of Studies in detail before presentation to the Faculty Board of the Faculty.

Prof. Dr. Ghulam Murtaza also briefed the Academic Council about revision of Scheme of Studies. The Chairman, Department of Forestry also took part in briefing the house regarding revision of Scheme of Studies relating to BS Forestry degree program.

The Academic Council observed that all Undergraduate Schemes of Studies of degree programs of the university are being revised in accordance with HEC Undergraduate Policy. These Revised Scheme of Studies have been included in Agenda of today's meeting of the Academic Council, which will be discussed by it under subsequent Items of the Agenda.

The Academic Council after holding a threadbare discussion and taking into consideration different academic pros and cons passed some instructions to follow by all faculties as follows:-

- As HEC new Undergraduate Policy allows flexibility, therefore, all teaching departments should deliberate on the issue of flexibility in Board of Studies meetings.
- b. All the independent degree programmes must have flexibility to entertain students admitted in other degree programs, if they want to change their admission after studying foundation semesters of their degree programme subject to clearance of some deficiency courses.
- c. The Deans of the Faculties should make arrangements to conduct online classes by making module and synchronized timetable of common courses.

- d. Teaching Assistants may be hired to assist for developing recoded lectures.
 The teaching material to be delivered to the students through modules should be placed as recordings. The recording may be uploaded on YouTube as well as UAF Website etc. to ease out the students.
- e. Each faculty will make its own arrangement of recording of teaching material. The services of TAs for this purpose can be hired from the Department of Computer Science.

f. The following committee will formulate recommendations to hire services of Teaching Assistants by the each faculty. The services of students as DPLs on hourly basis can also be hired. This Committee will ensure in consultation with Deans of the Faculties that general courses of thirty credit hours included in each Revised Scheme of Studies are uniform. The Committee will also ensure that basic/foundation courses in the Revised Scheme of studies are offered in the first four semesters:-

- g. As there is voluminous agenda of current meeting of the Academic Council, circulated among members as soft copies, therefore learned members can submit their valuable input for correction in the Revised Scheme of Studies through their respective Deans of Faculties to office of the Registrar before issuance of approval notification.
- h. The Deans of the Faculties will do brainstorming at departmental level to the issue of making joint appointment. The teacher appointed in a teaching department can also teach courses of other Teaching Departments

With the above instructions to the all Faculty Boards/Board of Studies, the Academic Council on the recommendations of the Faculty Board, Faculty of Agriculture made at its meeting held on 27-11-2023 recommended the Revised Scheme of Studies of B.Sc. (Hons) degree programs being offered by the Faculty of Agriculture as per detail given in relevant Appendix of Agenda Item, to be applicable w.e.f. Academic Session, 2024-25:-

Item No. 2 APPROVAL OF REVISED SCHEME OF STUDIES OF UNDER-GRADUATE DEGREE—INITIATION OF NEW UNDER- GRADUATE DEGREE PROGRAMS, FACULTY OF SCIENCES

Prof. Dr. Ijaz Ahmad Bhatti, Dean Faculty of Sciences brief the Academic Council about revision of Scheme of Studies of degree programmes of the Faculty of Sciences. He added that the observations made by the Academic Council at its previous meeting have been attended by the respective Board of Studies of the relevant teaching departments. The Faculty Board while considering recommendation regarding Revised Schemes of Studies of the Faculty has ensured that the Revised Schemes of Studies are in line with HEC Undergraduate Policy.
