In accordance with the statues and regulations relating to the Intermediate (Pre-Agriculture) Certificate, the undersigned being competent authority hereby allowed provisional admission to two-year Intermediate (Pre-Agriculture) Certificate, Winter Semester, 2018-19 in the relevant categories on **Open Merit Female (Urban), District-wise Male (Rural/Urban), Children of Overseas Pakistanis and Children of UAF employees** as per attached list. The admission of the candidates will however be subject to following conditions and completion of admission/enrolment formalities as detailed below:-

1. Deposit an amount of Rs. **30,000/- as Boarder** and **Rs. 16,000/- as Non-Boarder** fee on proper form received from admission office, into MCB and NBP account mentioned on the fee voucher, **Upto 14-09-2018.**
2. Submit the following documents to the office of the undersigned upto the said date for completion of other admission/enrolment formalities, **failing which their provisional admission shall stand cancelled and they shall have no claim whatsoever:-**
 - i. Original bank challan showing payment of above dues.
 - ii. Original educational documents for scrutiny and the short documents, if any.
 - iii. Prescribed courses enlistment form (IA-1) completed in all respects.
 - iv. Prescribed registration form along-with attested copies of Matric and CNIC/B-form.
 - v. Affidavit / undertaking on judicial paper worth Rs.200/- each as per specimen displayed on the Notice Board for desisting themselves from indulgence in '**Politics**' during their study period in the light of Orders of the August Supreme Court of Pakistan and good conduct/behaviour, abide by rules/regulations/instructions (within 15 days after admission).
3. Those who have submitted detail marks/result intimation of Matric examination along with admission application form, should produce attested copies of prescribed certificate immediately on receipt from the Board, failing which they can be restrained to continue further studies/cancel their admission.
4. In case any information/document attached with the application form is found **BOGUS/TEMPERED/FABRICATED etc.** at any stage of studies, the admission will be cancelled retrospectively without assigning any reason.
5. Errors and omissions, if any, in this notification are acceptable.
