

With a view to carrying out admissions in befitting manners and to facilitate new entrants, the Vice Chancellor has further approved:-

- i. To communicate the said remaining admission program to all admission authorities and other related offices for information.
- ii. That the provisional selection of candidates will be carried out according to decisions/modus operandi approved by the Academic Council at its meeting held on 30.07.2021.
- iii. That a Central Admission Office be established in the Farmer's Syndicate Hall located in the Faculty of Agriculture. The team of Scrutiny Committee members consisting the representatives from admission authorities of all the three Campuses will work in the admission office under the guidance of the Convenor Admission Committee. The said Committee will prepare merit lists of each degree in consultation with ITRCDB and Scrutiny Committee for onward transmission to concerned admission authorities for notifying admission according to the schedule.
- iv. That the Director, Students' Affairs will facilitate the new entrants with the assistance of Rover Scouts to provide necessary guidance. The flexes containing admission information and guiding towards Central Admission Office will be got prepared by the PRP Section for display at appropriate places of the Campus. The said Directorate will also keep an eye on activities of students of defunct political organizations.



- v. That the Senior Tutor will ensure the availability of atleast five Faculty members daily amongst the Tutors/Co-Tutors on rotation basis for attestation of the documents of new entrants, if required, and providing necessary guidance at Central Admission Office.
- vi. In order to simplify the admission procedure, it is also approved that:-
- after confirmation of provisional selection, each candidate interested to seek admission in a program of his choice, should deposit prescribed fee through online system from his/her hometown and bring a copy of fee challan with him while reporting to concerned Dean/Director/Principal Office for completion of other admission formalities, alongwith original and copies of testimonials.
 - after issuance of provisional admission notification, new entrants will submit medical fitness certificate and affidavits on judicial paper within the notified dates. The prescribed specimen of Medical Certificates and Affidavits will be available on University website. In case of non providing of these documents it would be presumed that the concerned candidate is not interested to seek admission. Consequently his/her provisional admission will be cancelled by the concerned admission authority. The medical fitness certificate issued by Medical Officer of a Government Hospital, MBBS Practitioner (registered with PMDC) or Medical Officer(s) of University, will be acceptable.
 - left over candidates will be accommodated subject to availability of seat(s) on the recommendations of the concerned admission authority after due approval of the Vice Chancellor in accordance with the relevant provisions.
 - availability of drinking water and sitting area will be ensured by the respective admission authorities at the respective vicinity.
 - sufficient number of University security personnel will be arranged by the Principal Officer(Estate Management) to maintain law-and-order in premises of each admission authority.


