- (2) It is clarified that being foreign students, they are exempted from Entry Test conducted by University.
- (3) The admitted candidates should submit fee, UG-I form and registration form immediately.
- (4) Mr. Kalyan Goswami from Bangladesh at serial No. 1 will provide proper Equivalence Certificate issued by Inter Board Committee of Chairmen (IBCC) Government of Pakistan within sixty (60) days from the issuance of this notification; failing which their provisional admission should stand cancelled.
- (5) Declaration for studies and undertaking for desisting of Politics on separate judicial papers worth Rs.200/- each as per specimen displayed on the Notice Boards and available on website.
- (6) Submission of Health Profile Form on the prescribed format available on website **within one month** after issuance of notification.

- (7) In case any information/data/document provided/indicated in on-line form or submitted thereafter in the University is found as **BOGUS/TAMPERED/ FABRICATED etc.** at any stage of studies, the admission shall be cancelled retrospectively without assigning any reason and the deposited fee shall not be refunded.
- (8) The undersigned being admission authority reserves the right to refuse admission to a candidate without assigning any reason, in accordance with the relevant provisions.
- (9) In case of any dispute the decision of the Competent authority, shall be final.
- (10) Errors and omissions, if any, in this notification are acceptable.
