NOTIFICATION – I

In exercise of the powers vested undersigned as per relevant provisions of Regulations, the undersigned being admission authority, hereby allow provisional admission/enrollment to B.Ed. Evening and Weekend Program, Spring Semester, 2024-25 as per attached lists. The admission of candidates will however, be subject to following conditions and completion of admission/enrollment formalities as detailed below:-

1. Deposit an amount of **Rs. 25,650/-** as **Non-Boarder** fee and **Rs.3750/-** as registration fee for students of other universities and **Rs. 16,150/-** for UAF Students on proper form received from admission office, into bank account mentioned on the fee voucher, **up to 21-02-2025**.
2. Submit the following documents to the office of the undersigned up to the said date for completion of other admission/enrolment formalities, **failing which their provisional admission shall stand cancelled and they shall have no claim whatsoever:-**
 - i. Original Bank Challan showing payment of above dues.
 - ii. Original educational documents for scrutiny and the short documents, if any.
 - iii. Prescribed courses enlistment form (UG-1) completed in all respects.
 - iv. Prescribed registration form along-with attested copies of Matric, intermediate, Bachelor Masters and CNIC/B-form.
 - v. Affidavit/undertaking on judicial paper worth Rs.400/- as per specimen displayed on the Notice Board for desisting themselves from indulgence in '**Politics**' during their study period in the light of Orders of the August Supreme Court of Pakistan (within 15 days after admission).
 - vi. Medical fitness certificate (within one month after admission).
 - vii. NOC from the last institute attendant (for outsider's students only)
3. Those who have submitted detail marks/result intimation of Matric and Intermediate examination along with admission application form, should produce attested copies of prescribed certificate from their concerned institute within one month of their admission on receipt from the Board, failing which they can be restrained to continue further studies/cancel their admission.
4. In case any information/document attached with the application form found **BOGUS/TEMPERED/FABRICATED etc.** at any stage of studies, the admission will be cancelled retrospectively without assigning any reason.
5. Errors and omissions, if any, in this notification are acceptable.
