***Conditions**

- For performance-based increment/honorarium, Faculty members (TTS/BPS) should have earned minimum research funding of Rs 3.0 million from projects as PI or equivalent (nomenclature such as Project Manager/Principal Investigator/Team Leader/Component Leader etc will be considered equivalent). Resources generated through consultancy will not substitute as the initial minimum funding requirement for performance-based increment/Honorarium.
- Publications: Minimum one publication in impact factor journal as 1st or corresponding author. In line with HEC policy, after Sept 15, 2021, research publications only in HEC recognized journals in HJRS, will be considered.
- For top awards, the limit of numbers in category B and C (10) will not be restricted (Development project excluded). Due to limited faculty members in FAH, teaching faculty of FAH and FVS will be treated as one group for top awards.
- The Best Team-Technology Transfer (TTT) award (multidisciplinary) will be on farm/industry demo showing substantial increase in yield/output/returns to farmer/industry, to be evaluated by a high-level committee including stakeholders. Best Innovation Award, Best Commercialized products Award will be determined by Committee to be notified.
- Awards comprise of a certificate and cash award as determined by Syndicate.
- Awards to be given at the Annual UAF Performance Review Ceremony-invited dignitaries/Media (highlights to be shown).
- Any complaint by the faculty regarding assessment/awards, be submitted to the Grievance Committee (to be notified).*
