UPLOADING OF DIFFERENT STATEMENTS BY THE STUDENTS ON INTERNET

It has been observed by the authorities that there is no mechanism to oversee/monitor the activities of the students in IT Labs of educational institutions. Any student can upload sectarian and anti-state statements on the internet which may aggravate the sentiments of masses, entailing any mishap/incident on broader scale. According to new law of the land, such unlawful activities are to be dealt with Cyber Crime Law, and culprits would be penalized by the court of law. In this scenario, Incharge and relevant staff of IT Labs are directed to keep a vigilant eye over the activities of students in IT Labs and ensure that no student uploads sectarian or anti-state statement on the internet or is able to use the facility for any unwanted communication. They are also directed to ensure that no unauthorized person or visitor etc. has access to the internet facility at the campus. A register should be maintained at each IT Lab to record each and every student/staff vs work station on certain date and time. If any such untraceable activity comes into the notice of the university authorities, the Incharge IT Lab will be held responsible.
